### UTAH SUBSTANCE ABUSE AND ANTI-VIOLENCE COORDINATING COUNCIL

#### **Agenda Item: Welcome and Approval of Minutes**

Chair Dr. James Mason welcomed all present and introductions were made. *A motion was made by Craig Dearden to approve the minutes of the January 26, 2000 meeting. The motion was seconded by Steve Laing and approved unanimously by the Council.*

#### **Agenda Item: National Youth Substance Abuse Prevention Initiative Proposal for USAAV Council to be Grant Advisory Group**

Dr. Steve Harrison, Associate Research Professor from the University of Utah Social Research Institute, addressed the Council. Dr. Harrison explained that the federal government, through the Center for Substance Abuse Prevention, is providing \$9 million over the next three years to develop a statewide substance abuse prevention program. The question was whether the USAAV Council would act as a grant advisory group and help coordinate the prevention activities going on throughout the state. The grant money would flow through the Governor's Office, with the State Division of Substance Abuse (SDSA) as grant manager. Pat Fleming explained that SDSA will assign a staff person to work directly with the USAAV Council on the grant and keep the Council informed. *Verne Larsen made a motion that the USAAV Council take on the responsibility to serve as the grant advisory group. The motion was seconded by Harold Morrill and was unanimously approved.* Dr. Mason asked that periodic reports be provided to USAAV from Pat Fleming or Steve Harrison regarding the status of the grant.

#### **Agenda Item: Election of Council Vice Chairman**

*Harold Morrill nominated Patrick Fleming as Vice-Chairman of the USAAV Council. Craig Dearden made a motion that nominations cease. Dick Melton seconded the motion, which was unanimously approved.*

### **Agenda Item: Recognition of Outgoing Council Member**

Dr. Mason presented Leon PoVey with a certificate signed by Governor Leavitt, designating him as an honorary member of the USAAV Council. He was recognized for his ten years of dedicated service to the Council and presented with tokens of the Council's appreciation for his many contributions to the substance abuse and anti-violence cause.

### **Agenda Item: Review of 2000 Utah Legislative Session**

Mary Lou gave an overview of how the Council fared during the 2000 Legislative Session. She noted that two of the Council's five priority bills passed: *H.B. 77 - Controlled Substances Amendments* (date rape drugs) and *H.B. 81 - Controlled Substances Precursor Amendments*. While discussing the tobacco settlement money, Dick Melton reported that the Utah Department of Health has formed a Tobacco Prevention Advisory Committee. They have put together a tentative distribution of funds, not in terms of who should receive them but what the area of impact should be. Verne Larsen felt strongly that a substance abuse prevention specialist and a Safe and Drug-Free Schools coordinator should be added to the current eight-member Tobacco Prevention Advisory Committee, as well as a representative of local health departments. *Harold Morrill made a motion to strongly encourage the Health Department to enhance coordination and prevent duplication of statewide prevention efforts, as well as do everything possible to enhance the Prevention Dimensions curriculum and resources needed to continue this in the schools.* Dick Melton agreed to bring these issues to the attention of Rod Betit for his consideration.

Dr. Mason asked for ideas as to how the Council could be more effective legislatively next year. Rep. Gary Cox suggested that the first line of business would be to look at the candidates that are running and see which have positions that align with the Council. Leon suggested that presentations to various committees regarding the Council priorities should begin earlier. Harold felt that meeting with the House and Senate leadership would be very helpful as well.

### **Agenda Item: Report from Domestic Violence Cabinet and Advisory Councils**

Diane Stuart reported that the Domestic Violence Cabinet Council meets quarterly. They have put together regional training around judicial districts with the emphasis being on a coordinated community response. Last June the Governor signed an Executive Order requesting each department to have a domestic violence policy in place. The departments are required to have their policies, or their progress, back to the Cabinet Council by July. Kris Knowlton noted that there were only two of the Domestic Violence Advisory Council's legislative bills that passed this last session, and no funding was forthcoming. The Domestic Violence Advisory Council is in the process of developing its own website.

### **Agenda Item: 2000-2001 USAAV Annual Report**

Dr. Mason reviewed Governor Leavitt's goal of reducing the rate of tobacco use, and alcohol and other drug abuse by 50% among youth, adult and youth offenders, and recipients of public assistance by the year 2010. It was agreed that USAAV should play a significant role in this. Dr. Mason suggested that individual members look at their own responsibilities and how they could focus efforts to help achieve this goal. The Governor's ten-year goal will be added to a new USAAV priority worksheet asking what each committee might do to contribute to the success of this goal.

### **Agenda Item: Boating Under the Influence Proposal**

Mary Phillips explained that an interim committee is looking at the "Boating Under the Influence" issue. They are currently researching the idea of a license, where a person would have to pass an exam in order to receive a boating license. This license would then be coded on the person's driver license. The committee is also looking at whether to take it one step further, so that if a DUI is committed, both licenses would be revoked. Any comments or suggestions should be directed to Bart Blackstock, director of the Driver License Division, at 965-4405.

With regard to legislation, Mayor JoAnn Seghini noted that half of what is done is public education and the other half is to get people actively involved. A large lobbying group is the Utah League of Cities and

Towns. They hold two conventions a year, with the next one scheduled for September. She suggested that it might be beneficial for USAAV to have a workshop at this convention addressing the community problems that exist because of substance abuse, domestic violence, and the lack of prevention programs. This would be one way to get every mayor in the state of Utah behind legislation that supports these concepts. Mayor Seghini volunteered to introduce any legislation to the Utah League of Cities and Towns Policy Committee and ask for their support. The Council expressed enthusiasm for this idea.
